Important Notice for MOP-UP Counselling

This is to Inform all eligible candidates and all concerned that on the vacant seats after admission on the basis of online 2nd Round Counselling of UGMAC-2021, offline MOP-UP counselling will start from 05.04.2022 at I.A.S. Bhawan, Near Patna Airport, Patna-800014 for admission to MBBS / BDS / B.V.Sc.&A.H. courses in Government / Private Medical / Dental Colleges and B.V.Sc. Colleges of Bihar.

MOP-UP ROUND COUNSELLING WILL BE OFFLINE.

2. UGMAC ID of all candidates, who have duly submitted the online application form for UGMAC-2021 Mop-up Counselling in the light of Adv. No. BCECEB(UGMAC)-2021/16 & 2021/17 dt. 23.03.2022 and found eligible as per the NEET Cutoff Marks and are not admitted in any Medical / Dental Colleges of India either through UGMAC-2021 1st and 2nd Round of Counselling or All India Quota Counselling are included Merit-row wise in the MOP-UP counselling programme mentioned below.

3. For admission in Govt./ Pvt. Medical / Dental/ B.V.Sc. colleges of Bihar state, only such NEET(UG)-2021 candidates are eligible who fulfill the eligibility criteria as per the prospectus and are not admitted in any Govt. / Pvt. Medical / Dental Colleges of India. **Candidates must have to bring their all original documents alongwith Rank Card for MOP-UP counselling at the time of counselling as mentioned in the prospectus of UGMAC-2021, otherwise they will not be considered eligible for attending MOP-UP counselling. The candidates admitted in B.V.Sc. & A.H. are eligible for this MOP-UP counselling.**

4(a). Fee structure for Govt. Medical / Dental / B.V.Sc. colleges and Pvt. Medical / Dental Colleges are uploaded on the Board's website.

(b) **Each candidate desirous of opting seats in any of mentioned Private Medical / Dental Colleges, has to come with all required original documents and a Bank Draft of Rs.12,00,000/- (Twelve lac) for Private Medical Colleges and Rs.50,000/- (Fifty thousand) for Pvt. Dental Colleges in favour of "Controller of Examination, BCECE Board" payable at Patna. If the candidate is allotted seat and doesn't take admission on his allotted seat, the deposited amount will be forfeited and in case of taking admission rest of the difference of fees have to be deposited at the allotted institute. In case of admission, the deposited security money will be transferred to the concerned Institution.** The candidates have to show the bank draft at the time of giving his/ her attendance at attendance counter and have to submit the required bank draft and original certificates at the entrance gate of counselling hall otherwise he / she will not be allowed to participate in counselling.

(c) If the candidate is allotted a seat in Govt. Medical / Dental / B.V.Sc. College, he / she has to take admission within the prescribed time with deposit of full prescribed fee and in case of Private Medical / Dental College, the candidates have also to take admission at their allotted colleges within prescribed time with deposit of rest of fees of concerned Institution, otherwise their deposited fees will also be forfeited.

(d). Candidates who opt for B.V.Sc. & A.H. Course in B.V.C., Patna have to submit a bond of Rs.3,00,000/- (Three lac) at the time of admission.

5. The UGMAC - ID of reserve category candidates who competed in Unreserved category have been included in Unreserved (UR) as well as in their respective reserved categories. The seat of reserved category will remain open during the counselling of UR category and MRC candidates present in UR merit list will have option to opt UR seat as well as there category seat. **Therefore, Meritorius Reserve Category (MRC) candidates who are included in Unreserved Category must come for counselling on the date fixed at their Unreserved Category merit serial as well as at their category merit serial on the day of counselling of their category for option of course / institution available in Unreserved category as well as reserve category,** otherwise the reserved category seat available at their merit Serial may be opted and allotted to the candidate of lower merit for which they themselves would be responsible.

6. All the registered candidates who are eligible as per criteria, have been called for MOP-UP Counselling as per counselling programme given below. The seat matrix is uploaded on the Board's website. During the counselling process, the vacancies will be updated and in case, if the seats filled up, counselling of the concerned category will be closed. In that case, the remaining candidates have to return back.

6. During any stage of Counselling / Document verification, if any candidate included in above merit list is found admitted in any Medical / Dental College of India he will not be eligible for seat allotment in this MOP-up counselling.

7. All the certificates included in the list given below, if applicable, must have to submit in original at the time of his/ her Counselling / Allotment on the scheduled date otherwise they shall not be eligible for counselling / admission ;

- Original Admit Card of NEET(UG)-2021.
- Downloaded print of Online filled Application Form (Part-A & Part-B) UGMAC-2021 (Mop-up Counselling).
- The Verification Slip (जाँच-पत्र) as downloaded alongwith Allotment order in 2 copies and Biometric Identification report form one copy.
- Rank Card of UGMAC-2021.
- Passing Certificate / Marks Sheet / Admit Card of Matric / equivalent Examination.
- Passing Certificate / Marks Sheet / Admit Card of Intermediate Sc / equivalent Examination.
- Certificate for Residence of Bihar duly issued by Concerned C.O. / Revenue Officer of permanent residence.
- Caste Certificate duly issued by Concerned C.O. / Revenue Officer.
- All the Certificates in original as per the requirements of the Prospectus of UGMAC-2021 (if applicable).
- Six copies of the passport size Photograph which was pasted on the Admit Card NEET(UG)-2021.
- Muslim Minority / Sikh candidates must come with the relevant documents which is necessary for proving their candidature.

8. NRI candidates have to submit all the required certificates positively during the counselling as prescribed in the format provided by MCC for NRI Quota. The prescribed format and other details may be downloaded from Board's website by clicking the link "**Guidelines for NRI Quota**".

9. Inclusion of any UGMAC-ID in the above Counselling programme does not guarantee admission. Since candidates in excess of the available seats are being called for Counselling / Allotment in order to ensure filling up vacancies which may arise due to absentees, those having merit positions lower than the total number of sanctioned seats will be admitted subject to availability of seats.

10. (a) If the counselling does not complete on scheduled date, the concerned candidates have to stay on the next day in order to complete it.

(b) If the available seats are filled before the scheduled date and time, the counselling will be postponed / discontinued.

11. If a candidate called for MOP-UP Counselling / Allotment is found ineligible as per the requirements of the prospectus of UGMAC-2021 and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court Apex Bodies or Department of Health in matters related to UGMAC-2021, his / her candidature is liable to be rejected.

12. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those institutions & seats available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.

13. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Allotment may appear for Counselling any time during the period of Counselling of their respective category but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting at allotment table.

14. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling in his/ her concerned category for which his/ her choice is allowed and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution in the same category shall be entertained.

15. The updated vacancy position of seat for MOP-UP Counselling can be seen on Board's Website. The available vacancies may change at the time of starting Counselling on 05.04.2022 and will be updated as mentioned above.

16. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.

17. The Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to UGMAC-2021.

18. Other terms and condition as given earlier vide Advertisement No. BCECEB (UGMAC)-2021/16 dt. 23.03.2022 will remain the same.

19. Any typographical error inspite of all precautions taken and detected any time shall be corrected whenever detected and merely publication of UGMAC-ID will not confer any right for admission.
